Legislative Review Session
July 27, 2015
6:30 P.M.

Pres. Eallonardo called to order the legislative review session with the following eight members present: Ames, Fleurima, Gray, Neal, Patrick, Proehl, Tatman and Trutschel. (Mrs. Corcoran absent.) There were 1 media representative and 6 other visitors present, in addition to Mayor Everson and City Auditor Feeney.

Pres. Eallonardo called upon Mr. Trutschel to lead tonight's discussion on the sole topic on the agenda, the new website of the City Auditor's Office on the city's financial information. Mr. Trutschel called upon City Auditor Feeney to make his presentation to Council.

City Auditor Feeney said that Aubrey Camberon from his office is also here with him tonight to assist him with the power point presentation on the new website. Mr. Feeney began by giving a brief overview of what the State of Ohio is doing with its website, www.ohiocheckbook.com. He said that this was put together by the State Treasurer's Office in order to help cities become more transparent with their financial information by putting their checkbook transactions online. However, he said that the City of Chillicothe is not doing this yet. Mr. Feeney indicated that the city will be getting a 10% reduction on the annual cost of the system that has been set up with Opengov. He said that Chillicothe's new website, www.chillicothe.oh.opengov.com, puts basically everything else except the checkbook transactions online. He then referred everyone to the materials he passed out, including reduced copies of the power point presentation. He indicated that this website will be live online, and interactive, during tonight's meeting.

Mr. Feeney then proceeded to describe in detail how the system operates, stating that Council members can track both revenue and expenses, and that members of the public can submit questions. He then announced that "now we will go live", as he and Ms. Camberon linked up the computer hookup to the Internet. Mr. Feeney then demonstrated how the website works.

Mrs. Corcoran arrived at 6:50 p.m.

As Mr. Feeney went through the steps, he stated that it is a work in progress and that the terminology and definitions will be refined.

Using the information shown on the website, and information also contained in the materials passed out, Mr. Feeney commented on the current status of the City's finances. He said that the increase in revenues this year in the general fund is almost entirely due to an increase in income tax receipts, and that the general fund is up about \$337,000.00 to date. He noted that the main decrease is due to the fact that city pool revenue has been pulled out of the general fund for accounting purposes. He said that both EMS fees and refuse collections are essentially the same as they were at this time last year. Otherwise, he indicated that most of the funds are on pace with this year's projections, or with where they were at this same time last year. The one exception, he stated, is the Transit Department, where there is a difference of about \$400,000.00 between this year as compared to last year at this same time. That difference, he explained, is mostly due to the fact that ODOT is withholding about \$400,000.00 in payments as a result of compliance issues.

Mr. Feeney said that the total revenue brought in by the city during the first six months represents about 56% of what was projected for the entire year. We are in good shape as far as building permits, he said, and he also indicated that the income tax collection agency, CCA, has brought in \$38,285.00 through the 30th of June. Mr. Feeney noted that Amy Wagner has transferred from the Chillicothe Municipal Court to the Auditor's Income Tax Office, where she has been working on income tax enforcement and collections. He said that a separate sheet among the passouts shows what a good job she has been doing. As for the safety forces, he said that the Chillicothe Police Department is right at 50% of what was budgeted for the year, after the first six months, but that there are some caveats for the remainder of the year. The Chillicothe Fire Department is at 54% of its annual budget after the first six months, but he said that they had retirements and other factors that caused their expenses to be greater than expected. City Auditor Feeney referred to charts and graphs on the website as he spoke, and he concluded by saying that we need to get our revenues to exceed our expenses in order to increase the anticipated carryover balance at the end of the year to about 8% of the annual budget, whereas presently we are only running at about 5%.

No formal action was taken by Council on any matter discussed during the legislative review session, and no roll call votes were taken.

The legislative review session adjourned, by consensus, at 7:18 p.m.

Council met in regular session with all nine members present: Ames, Corcoran, Fleurima, Gray, Neal, Patrick, Proehl, Tatman and Trutschel. There were two media representatives and sixteen other visitors present, in addition to Mayor Everson and City Auditor Feeney.

Pres. Eallonardo led in the Pledge of Allegiance to the Flag.

Mrs. Patrick noted that on page 941 of the minutes for the regular meeting of the 13th of July, the name “Rhonda Erving” should be corrected to “Rhonda Lurty” at the beginning of the first paragraph under the heading Audience Participation. Subject to this correction, Mrs. Patrick moved and Mrs. Corcoran seconded that the minutes for the legislative review session of July 13, 2015; the minutes for the public hearing of July 13, 2015; and the minutes for the regular meeting of July 13, 2015, be accepted and approved, as otherwise submitted by the Clerk. All members present voted “yea”, and Pres. Eallonardo declared the motion adopted.

COMMITTEE REPORTS

Utilities/Transit Committee:

Mrs. Patrick reported on Item #3 to appropriate \$20,000.00 for the extension of an eight inch water main to the east side of North Bridge Street at Hopetown Road, on tonight’s agenda for its second reading. Mrs. Patrick reported on Item #11 to appropriate \$43,770.00 for coating the clarifier weirs and interior at the Wastewater Treatment Plant, on tonight’s agenda for its first reading. Mrs. Patrick reported on Item #12 to appropriate \$50,000.00 to rehab water wells #20 and #22, on tonight’s agenda for its first reading. Mrs. Patrick reported on Item #13 to accept and adopt the revised City Drug & Alcohol Testing Policy for the Transit Department, on tonight’s agenda for its first reading. She said that she will seek to pass this item tonight because ODOT is requiring that this be adopted by the 31st of July. Mrs. Patrick reported on Item #10 to declare a real and present emergency requiring the repair of a concrete sanitary sewer line on East Water Street, and appropriate \$150,000.00 for said repair, on tonight’s agenda for its first reading. She called upon City Utilities Director Richard Johnson, P.E., to explain the urgent need that this legislation be passed tonight. Mr. Johnson said that there is an immediate need to replace this 21 inch main sewer line because sewer gas reacted with the concrete line at the intersection of Water Street and Poplar Street, causing it to collapse. He said that there is now a 15 feet deep hole there, and that city crews have been working nonstop for the past two weeks to repair it and to determine the extent of the problem. He indicated that it will be necessary to reline the sewer line from this location at least as far as to the Mount Logan School a distance of 1,010 feet, after the line has first been cleaned out. He said the collapse occurred during the heavy downpour of rain, and that once the line collapsed, all of the dirt, gravel, asphalt and debris above got sucked into the line that services much of the area on the east side of town and south of the Scioto River. Mrs. Patrick said that she will seek to pass this item tonight, and she expressed her thanks to Bob Gillum for loaning his track hoe to the city.

Safety Services Committee:

Mr. Proehl reported on Item #5 to declare certain vehicles obsolete or not needed and authorizing the Safety Service Director to sell said vehicles simultaneously with the purchase/lease of three new police cruisers, on tonight's agenda for its second reading. Mr. Proehl reported on Item #6 to appropriate funds for the purchase, lease and cost of outfitting three cruisers for the Chillicothe Police Department, on tonight's agenda for its second reading. He noted that a substitute version of this ordinance was distributed in Friday's legislative packet. Mr. Proehl moved and Ms. Gray seconded that Item #6 be amended by substituting this new version of the ordinance for the original version. All members present voted "yea" and Pres. Eallonardo declared the motion adopted. Mr. Proehl then provided an explanation of the source of the funding under this new version.

Human Resources Committee:

Ms. Gray reported on Item #7 to authorize the administration to hire two additional police officers and to appropriate \$76,920.00 for salary and fringes, on tonight's agenda for its second reading. She noted that a substitute version of this ordinance was also distributed with Friday's legislative packet, with the only change being to change the amount appropriated to \$77,237.46. Ms. Gray moved and Mr. Trutschel seconded that Item #7 be amended by substituting this new version of the ordinance for the original version. All members present voted "yea" and Pres. Eallonardo declared the motion adopted. Ms. Gray called upon Police Chief Washburn to speak to Council in support of passage of this ordinance tonight. Chief Washburn first explained how he arrived at the amount needed to be appropriated, and then indicated that because the current civil service eligibility list expires on the 31st of July, the city will actually save about \$54,000.00 by passing this ordinance tonight. He said that there are two individuals on the current list who have already passed all the tests and background checks, and who also have taken the necessary peace officer training. He further indicated that if this eligibility list expires, it will be months before another list becomes available with the solicitation for applicants, the scheduling of testing followed by background checks, and then the city would likely have to pay the cost for peace officer training. This would result in increased overtime due to the department being understaffed, he stated, noting that the department is presently 16 officers shy of its authorized level of strength. Chief Washburn discussed the increasing demands upon his officers, reporting that in the past week alone they have dealt with a very serious sexual assault incident, as well as a number of break-ins of cars and homes. He said that in addition, they executed two high risk search warrants, and that these two new officers are critically needed to be brought on board as soon as possible. Ms. Gray said that she will seek to pass Item #7 tonight. Pres. Eallonardo ruled that both Item #6 and Item #7 will remain at second reading status tonight because the amendments do not represent substantial changes.

Finance Committee:

Mr. Trutschel reported on Item #2 to authorize the addition of traffic controllers located within the city to the City's property insurance policy at an initial cost of \$6,262.50, on tonight's agenda for its second reading. He again reported that it was discovered after a traffic accident last October that none of the traffic control equipment throughout the city was covered under our city insurance policy. Fortunately, he indicated that the motorist who crashed into our controller had liability insurance. However, Mr. Trutschel said that it was determined that if an uninsured motorist were to hit one of our controllers, or if one were damaged due to other casualty, it could cost the city as much as \$100,000.00, and so the sum of just over six thousand dollars is a wise investment to insure our controllers. He concluded by saying that in order to get this insurance in place without further delay, before any such loss occurs, he will seek to pass this item tonight.

Engineering Committee:

Mr. Tatman reported on Item #1 to authorize the removal of the school designation for all traffic control and all school signage relating to the now closed Western Elementary School and Smith Middle School, within the City of Chillicothe, Ohio, on tonight's agenda for its third reading. Mr. Tatman reported on Item #8 to provide for the issuance of not to exceed \$2,000,000.00 of notes for the payment of the cost of improvements to various city roads, including sidewalks, curbs, gutters and all necessary appurtenances, on tonight's agenda for its first reading. He said that the Engineering Committee had another meeting to discuss this proposal to borrow these funds in

anticipation of the new income tax revenues coming in next year under the levy passed by the voters in May. Mr. Tatman said that concerns were expressed about the fact that work might not be completed in the few months remaining this year before winter weather arrives. He said the decision was made to go ahead with securing the funds now to get started with what can be done now, since the money not spent in 2015 will still be there when the construction season begins next year. Mr. Tatman reported on Item #9 to establish new traffic lane patterns and to implement angle parking on South Paint Street between Main Street and Fifth Street, on tonight's agenda for its first reading. He said that this is in keeping with a resolution previously passed by Council in connection with the Carlisle Building reconstruction project, and that once implemented it will bring about a significant number of additional parking spaces for the downtown area.

Development Committee:

Mrs. Ames said that the Development Committee has nothing on tonight's agenda, but she wished to report on council committee assignment #15-57. She said that this dealt with establishing a permit system for downtown restaurants and liquor permit holders to set up sidewalk areas for their customers. Mrs. Ames indicated that Sean Immell had requested that whatever practice the city adopted be in compliance with the applicable regulations of the Ohio Division of Liquor Control. She said that Mayor Everson issued a letter that complies with the regulations, and that this was then signed by Mr. Immell. She indicated that the owner of "Time Out" is now seeking a similar letter. Mrs. Ames indicated that it has been determined that no action by Council is needed to continue this system, and that she is therefore reporting assignment #15-57 out of committee at this time.

REPORTS OF OFFICIALS

Report of Mayor Everson:

Mayor Everson said that last Friday there was an initial meeting of the newly established local Heroin Partnership Project. He said that they decided to use some of the \$100,000.00 they received in initial funding for the purpose of hiring a professional coordinator. Mayor Everson announced that on Thursday, at 9:30 a.m., there will be a meeting of the stormwater management committee in the Mayor's conference room. He reported that the early wage reopeners on the recently ratified union contracts are underway, and that the City's labor negotiator, Brian Butcher, will be providing Council with reports on the status of the negotiations in the future. Mayor Everson indicated that there will be paving of Washington Avenue on Thursday and Friday. He reported that the City's contract in connection with the RossGo program has been extended to the 30th of September, and that legislation will be needed on this. Mayor Everson concluded his report by commenting on a near tragic incident that occurred last week involving officers of the Chillicothe Police Department. He said that a masked subject confronted the police with what turned out to be an air rifle, and that this had the potential of becoming a police involved shooting similar to what took place in Beaver Creek, Cincinnati and Cleveland. However, he said that cool heads prevailed and that the local police did a good job, with the subject being taken into custody unharmed. Mayor Everson said that in his opinion this attests to the exceptional training and experience of the officers of the Chillicothe Police Department, and that he commends them for this.

Report of Auditor Feeney:

City Auditor Feeney commented on Item #2, urging Council to pass this authorization to insure the city's traffic controllers. He also urged Council to pass Item #6, echoing Mr. Proehl's statements in support of the lease-purchase of the three new cruisers. He said that this is more of a lease to own, with the final payment being only one dollar. Mr. Feeney said that he recently had a ride-along a couple weeks ago and that this convinced him that the police cruisers need replaced. He commented on Item #7, stating that Chief Washburn provided a very good breakdown of the costs and of the costs savings of the hiring of these two new officers at this time. He also said that this has nothing to do with the recent passage of the safety levy, but instead is being covered by this year's money. Next, he commented on Item #8, stating that the city decided to borrow the whole \$2,000,000.00 this year even though it could not be spent this year. He explained that this not only has the benefit of saving on bond financing costs that would be incurred if broken into two separate issues of one now and one later, but that it also allows us to go out now on bids on the work with some repaving being done before the harsh winter weather causes even further damage to the roads that we can get repaired this year. He said that if we do not borrow money, none of the work will probably begin before 2017, after collecting the taxes in 2016. He said that we must also keep in mind that interest rates could be higher next year for this type of funding.

Mr. Feeney concluded his report by declaring that www.chillicothe.oh.opengov.com is now up and running.

AUDIENCE PARTICIPATION

Officer Chris McGowan of the Chillicothe Police Department, 28 North Paint Street, thanked Council and the administration for bringing forward the legislation to hire the two new police officers and to purchase the three new police cruisers, stating that the older cruisers are in very bad shape and that the department is severely understaffed. He said that the city was crazy this past week, as alluded to by Mayor Everson. He indicated that he works the third shift beginning at 11:00 p.m., and he invited each member of Council to come on a ride-along to see what goes on during that shift. He said that the crime rate locally is up substantially compared to what it was like in the past, when things used to quiet down after midnight. It is now very busy during the third shift most every night, and he said that the city is doing the right thing by bringing in the new officers now, before the current eligibility list expires. He said that some of the former officers that were laid off could not continue to wait to be recalled, and that one laid off officer was lost because he finally gave up and joined the U.S. Coast Guard.

Alan Davis of 370 Braewood spoke to Council, saying that he is here tonight to discuss what he believes are the four principles of good financial planning. First, he said that the city should always strive to maintain adequate reserves. Secondly, he said that each year the city must have a surplus of revenues over expenditures, not simply a balanced budget, in order to have a healthy carryover balance. Third, he stated that it is imperative to always budget for the upkeep of the city's property, including structures, vehicles and other equipment, as well as for improvements to the city's infrastructure. Finally, he said that the city must have good and reliable projections of both anticipated revenues and expenditures. Mr. Davis urged the members of Council and the administration to remember these four principles. He said that unfortunately, these principles were not always followed prior to the current Mayor and the current City Auditor. Mr. Davis then talked about his own experience in budgeting and planning, stating that he does not envy Council as it deals with the city's finances.

Connie Riley of 256 Church Street said that she saw in the local paper where we are going to start the process of setting up drug treatment facilities for residential treatment of addicts. She said that she understands that one individual has even claimed to have acquired properties for the siting of five person centers. She stated that she cannot understand why the local authorities are proceeding with such plans when they are clearly unable to even handle the homeless problem. Ms. Riley then discussed at length the many problems that she perceives to be associated with the proposed residential drug treatment centers, including the failure to enforce building codes, zoning codes and other regulations. She said that there will be problems in the neighborhoods where these are located, as there have been already in some neighborhoods with other group type homes. She said that if one checks with the hospitals to the south, their staff will tell you that most of the patients who present as victims of drug overdoses come from these drug treatment facilities. Ms. Riley proceeded to discuss the additional problems that she anticipates to develop as a result of any local establishment of similar residential drug treatment facilities.

City Utilities Director Richard Johnson, P.E., of 131 Yaples Drive, once again spoke to Council, saying that earlier when he spoke, he forgot to recognize the 14 or 15 city employees who have worked so long and hard during the past two weeks, on the crew making the emergency repairs to the collapsed Water Street sewer line. He then also discussed the five year capital improvement plan of the Utilities Department, where the repair of the Water Street sewer line has been listed as the #1 priority for years. He then distributed copies of the plan with this item highlighted to show this. Mr. Johnson said that he attended a convention in St. Louis this past weekend, where he said that at least five people, upon learning that he is from Chillicothe, asked him about the bad news reported in the national news concerning Chillicothe. Mr. Johnson stated that he thinks that the Chillicothe Police Department and the city administration have been doing an excellent job with the resources available to them, and that Chillicothe does not deserve the negative perception that has developed as a result of the tragic events that are the subject of these news articles.

William Barnhart of 373 McKeller spoke to Council about recycling, saying that for the past three years City Council and Mayor Everson have completely ignored this subject that he has himself mentioned in prior appearances before Council. He again stated that the city needs to set up a recycling program in order to reduce the tonnage going to the landfill and the tipping fees

incurred. Next, he again urged the city to get completely out of the garbage business because it is too costly, and he claimed that the city should instead hire Rumpke. Mr. Barnhart then complained about the fact that the city put in gates to the east of the walking/bicycle path, which he described as a waste of taxpayer money. He concluded his remarks by complaining about the city's plan to expend public funds to repair or replace the steps going up to the top of the floodwall, near the Pump House Art Gallery in Yoctangee Park. He said that the Chillicothe Morning Rotary Club has offered to cover this expense as one of their civic projects, but that Council and the city apparently prefer to do this with taxpayer money.

OLD BUSINESS

Mrs. Neal inquired of Mrs. Ames about the downtown sidewalk permits, asking whether these applications are not something that the Design Review Board should consider. Mrs. Ames said that there are already strict guidelines set up by the Ohio Division of Liquor Control, but that perhaps the Design Review Board should also be involved. Mrs. Neal said that she is thinking that if the applicant is planning to fence off the area, the Design Review Board might have a preference with respect to the materials to be used, or with respect to the types of tables permitted. Pres. Eallonardo said that there could also be questions about feather flags, and umbrellas. She said that in her capacity as the director of the Design Review Board, she will raise this issue at their next meeting.

Mr. Trutschel said that on the subject of the issuance of the \$2,000,000.00 of notes to pay the cost of improvements to various city roads, he thinks that we need to make every effort to do the paving of the streets in Hesswood Hills in 2015. He once again reminded everyone that the residents of Hesswood Hills were at the forefront in supporting passage of the street improvements levy both times it appeared on the ballot. He said that during the last successful campaign, those same residents showed up in force at Allen Elementary School for the town hall meeting to discuss the levy, and that they deserve credit for drumming up support for the levy all over town. Mr. Trutschel urged the decision makers, who select the roads for improvement this year, to not forget the people from Hesswood Hills who were so supportive of passage of the levy.

Mr. Proehl indicated that he will seek to pass Item #5 and Item #6 tonight.

PETITIONS AND CORRESPONDENCE

The clerk reported on receipt of a letter from the Ohio EPA on the subject of self monitoring report violations from May, 2014, through May, 2015, in reference to the Chillicothe Wastewater Treatment Plant.

CALENDAR AND MEETING DATES

Ms. Gray announced that there will be a regular meeting of the Chillicothe Civil Service Commission this coming Thursday, at 4:30 p.m., at the Chillicothe Transit Facility conference room, located at Watt Street and East Seventh Street.

READING AND PASSAGE OF LEGISLATION

Ord. No. 72-15 authorizing the removal of the school designation for traffic control and all school traffic signage relating to the now closed Western Elementary School and Smith Middle School, within the City of Chillicothe, Ohio, was read for the third time by title only. On final passage, all members present voted "yea" and Pres. Eallonardo declared Ordinance No. 72-15 adopted.

Ord. No. 73-15 authorizing the appropriate city officials to add traffic controllers located within the City of Chillicothe to the City's property insurance policy at an initial cost of \$6,262.50, and declaring an emergency was read for the second time by title only. Mr. Trutschel moved and Mrs. Ames seconded that the three reading rule be suspended, placing this item on final passage. All members present voted "yea" and Pres. Eallonardo declared the rule suspended. All members present then voted "yea" on the item itself, and Pres. Eallonardo declared Ordinance No. 73-15 adopted.

An ordinance appropriating \$20,000.00 for the extension of an eight-inch water main to the east side of North Bridge Street at Hopetown Road, and declaring an emergency, was read for the second time by title only.

An ordinance appropriating funds for the implementation of an off-site data backup solution for the City Income Tax Department, and declaring an emergency, was read for the second time by title only.

Ord. No. 74-15 declaring certain vehicles obsolete or not needed and authorizing the Safety-Service Director to sell said vehicles simultaneously with the purchase/lease of three new vehicles, and declaring an emergency, was read for the second time by title only. Mr. Proehl moved and Mrs. Patrick seconded that the three reading rule be suspended, placing this item on final passage. All members present voted “yea” and Pres. Eallonardo declared the rule suspended. All members present then voted “yea” on the item itself, and Pres. Eallonardo declared Ordinance No. 74-15 adopted.

Ord. No. 75-15 reallocating funds originally appropriated for the purchase of one police cruiser to be used for the lease purchase and outfitting of three cruisers for the Chillicothe Police Department, appropriating funds from the Law Enforcement Trust Fund to cover the balance due on the cruisers, and declaring an emergency was read for the second time by title only. Mr. Proehl moved and Mrs. Patrick seconded that the three reading rule be suspended, placing this item on final passage. All members present voted “yea” and Pres. Eallonardo declared the rule suspended. All members present then voted “yea” on the item itself, and Pres. Eallonardo declared Ordinance No. 75-15 adopted.

Ord. No. 76-15 authorizing the administration to hire two additional police officers, appropriating \$77,237.46 for salary and fringes, and declaring an emergency, was read for the second time by title only. Ms. Gray moved and Mrs. Ames seconded that the three reading rule be suspended, placing this item on final passage. All members present voted “yea” and Pres. Eallonardo declared the rule suspended. All members present then voted “yea” on the item itself, and Pres. Eallonardo declared Ordinance No. 76-15 adopted.

Ord. No. 77-15 providing for the issuance of not to exceed \$2,000,000 of notes by the City of Chillicothe, Ohio, in anticipation of the issuance of bonds for the purpose of paying the cost of improvements to various city roads, including sidewalks, curbs, gutters and all necessary appurtenances, and declaring an emergency, was read for the first time by title only. Mr. Tatman moved and Mr. Fleurima seconded that the three reading rule be suspended, placing this item on final passage. All members present voted “yea” and Pres. Eallonardo declared the rule suspended. All members present then voted “yea” on the item itself, and Pres. Eallonardo declared Ordinance No. 77-15 adopted.

An ordinance establishing new traffic lane patterns and implementing angle parking on South Paint Street between Main Street and Fifth Street was read for the first time by title only.

Ord. No. 78-15 declaring a real and present emergency requiring the repair of a concrete sanitary sewer line on East Water Street, appropriating the sum of \$150,000.00 from unappropriated sewer funds for said repair, and declaring an emergency was read for the first time by title only. Mrs. Patrick moved and Mr. Proehl seconded that the three reading rule be suspended, placing this item on final passage. All members present voted “yea” and Pres. Eallonardo declared the rule suspended. All members present then voted “yea” on the item itself, and Pres. Eallonardo declared Ordinance No. 78-15 adopted.

An ordinance appropriating \$43,770.00 for coating the clarifier weirs and interior at the Wastewater Treatment Plant, and declaring an emergency was read for the first time by title only.

An ordinance appropriating the sum of \$50,000.00 to rehab water wells #20 and #22, and declaring an emergency was read for the first time by title only.

Ord. No. 79-15 accepting and adopting the revised City Drug & Alcohol Testing Policy for the Transit Department, and declaring an emergency was read for the first time by title only. Mrs. Patrick moved and Mr. Proehl seconded that the three reading rule be suspended, placing this item on final passage. All members present voted “yea” and Pres. Eallonardo declared the rule suspended. All members present then voted “yea” on the item itself, and Pres. Eallonardo declared Ordinance No. 79-15 adopted.

Mr. Trutschel moved and Mr. Fleurima seconded that the regular meeting be adjourned. All members present voted "yea" and Pres. Eallonardo declared the motion adopted. Adjourned at 8:30 p.m.
